BACKSCATTER

125 Years Ago: Politicians and electricity: Units for the measurement of electrical magnitudes were adopted into U.S. law by President Grover Cleveland "to define and establish the units of electrical measure" for the ohm, ampere, volt, coulomb, farad, joule, watt and henry. Extra credit given to anyone who knows the difference between a joule and a watt.

122 Years Ago: Guglielmo Marconi received a U.S. patent for a wireless telegraph (No. 586,193).

67 Years Ago: The first Dayton Hamvention, originally known as the Southwestern Ohio Ham-vention, is held in downtown Dayton, attracting 600 attendees. After peaking around 35,000 in 1994, recent attendance has been as high 29,296 in 2017.

40 Years Ago: LCARA's 1st Field Day is history! Held at an abandoned farm in Thompson, the ambiance is perfect for an emergency prepardedness test. There is a freshly burned barn, a ruined house, and an equipment shed open on one side, but crushed on the other. Despite temperatures dipping into the mid 40's, 1010 Q's are made.

The FCC adopts a Notice of Inquiry into implementation of a Personal Radio Service at 900 MHz.

35 Years Ago: Mentor proposes an antenna ordinance that would limit antenna height to as low as <u>eight</u> feet, with none allowed on the roof. Fortunately, a sharp eyed ham catches a small notice in the News Herald about the proposed zoning ordinance, and over 40 hams appear at the commission's meeting. A new proposal is hammered out the following week, allowing antennas up to 60', as long as they are at least 20' from the property line.

Thanks to the Freedom on Information act, the FCC's file on the Russian Woodpecker becomes public. "The signal (of this over-the-horizon radar) has a repetition rate of ten pulses per second. It's bandwidth varies from 30 KHz to 500 KHz. Its activity does not appear to have any definite pattern. It may stay on a given band for only a few seconds, or it may remain constant for several hours ... It has been observed throughout the HF spectrum from 6 MHz to 28 MHz." Several transmitters are identified, one near Minsk, a second on the east coast of Siberia, and a third one near the Mongolian border in Abalakovo.

Backscatter cont'd.

30 Years Ago: Dr. Deviation, otherwise known as Rusty, WA8HAR will be the program at the July meeting. He will have a spectrum analyzer and other equipment to measure the deviation and performance of any member's HT, and wx permitting, mobile rigs as well.

25 Years Ago: Rusty, WA8HAR resign as Radio Officer. Eric, KF8YK has agreed to take Rusty's place.

The Friday Ham Lunch moves to the Lithuanian House on East 185th Street. This is definite-LY an improvement from the previous Burger King venue.

The FCC announces they will auction off three ham bands. Hams lose allocations at 2390-2400 MHz, 2402-2417 MHz, and 4660-4685 MHz. Bob, K8BL points out we can be comforted by the knowledge the funds raised by the auction will be used wisely by our representatives in Washington.

20 Years Ago: While Riley Hollingsworth was addressing a forum at the Dayton Hamvention, two of his inspectors were doing a different job. Dressed as convention attendees, they were looking for violations of the various FCC rules, including power amps capable of operating on 11 meters. Three exhibitors were found with such amps, as well as two manufacturers displaying export-only amps without a disclaimer that the model was not for sale in the US. All were warned that future violations would result in a minimum \$7000 fine.

The Morse Code debate makes the front page of the Wall Street Journal. In an article by staff reporter Lee Gomes headlined "TO HAM OPERATORS, MORSE CODE TEST IS LIKE LATIN EXAM: Does It Keep the Barbarians At Bay, or Is It Fueling The Decline of a Culture?" the code versus no-code debate is discussed. "Morse Code is a dying language in the Digital Age, but it's still required reading for amateur radio buffs" Gomes' story begins. He cites Bruce Perens, K6BP of No Code International, who in Gomes words, considers Morse code "an antiquated technology" and "a turnoff for young people." "Perens is in the minority" Gomes asserts. "Most licensees don't want any change in the requirement – especially since they have already passed the test themselves." Perens points out that applicants still will have to pass "rigorous tests" to get a ticket, besides "the riffraff have no reason to leave the Internet." The article is silent on the issue of ITU regulations requiring Morse proficiency for HF operation, and at one point refers to Morse code as "dits and duhs."

Backscatter cont'd.

15 Years Ago: AMSAT Echo is launched from the Russian Baikonur Cosmodrome. Initial telemetry looks excellent.

10 Years Ago: The July meeting is held at Penitentiary Glen Park in Willoughby.

6 Years Ago: The world's last telegram was sent in India, the last major country to shut down telegram service. The 163-year-old service was no longer needed, as e-mail and texting had replaced bicycle telegram messengers. In Great Britain, telegram delivery ceased in 2008, while the U.S it was terminated in January of 2006.

SRI LANKA, 4S. Kamal, 4S7AB has been QRV using FT8 on 6 meters.

HONDURAS, HR. John, AD8J will be QRV as HR9/AD8J from Guanaja Island, IOTA NA-057, from June 22 to July 6. Activity will be holiday style on 80 to 10 meters using CW, SSB and FT8.

CANADA, VE. Special event station XN1M is QRV until July 21 to commemorate the 1969 Apollo 11 mission.

LAOS, XW. Bruce, 3W3B will be QRV as XW4XR from Vientiane from June 26 to July 7. Activity will be on 40 to 6 meters, including 60 meters, using CW, RTTY, JT65 and FT8.

KOSOVO Z6. Z32ZM, Mome, will go to Kosovo where he will be for the entire month of July and possibly into August, if 6 meter conditions are good for DX. He will be using his new Z68MA callsign

SABA, ST. EUSTATIUS, PJ5. Dave, W9DR will be QRV as PJ5/W9DR from Sint Eustatius from June 25 to July 2. Activity will be on 6 meters only using SSB.

SOUTH SUDAN, Z8. Diya, YI1DZ is QRV as Z81D and plans to be active from Juba after June 22. Activity will be in his spare time on 80 to 10 meters using SSB and various digital modes.

MOUNT ATHOS, **SV/A**. "Mount Athos will not go dark" as SV2RSG, Monk lakovos, located at the Koutloumousiou Monastery is expected to be operating in the future from the 20th ranked Club Log DXCC

TUVALU, T2. 3D2AG, Tony, expects his next T2AR "mini-DXpedition" to be on the air from June 27 to July 6. Listen for him to be operating on CW, SSB, FT8 and RTTY on 1.8 through 28 MHz, including 60 meters.

SOUTH SUDAN, Z8. Z81D, Diya, now has antennas for 30 and 60 meters to operate on FT8 around 1930Z.

GEORGIA, 4L. 4L/DL7ZM will be on the air July 13-21, 6m CW, SSB and FT8.

FRENCH POLYNESIA, FO. FO/AI5P, Rick, goes holiday style July 22-29, primarily on 40-17 CW and FT8,

ISLE OF MAN, GD. - WJ2O, Dave, plans to be here and QRV as MD/WJ2O from July 11 to 17, including a high-power, mixed mode, all band effort in the IARU HF World Championship.

ARUBA, P4. Starting July 11th W2GD, John, will be back at his Aruba QTH operating as P44W until July 16th, including the IARU HF World Championship. Activity will be mostly on CW on 1.8 through 28 MHz.

AFGHANISTAN, T6. - S53R, Robert, will be on a two year assignment with the UN World Food Program. He plans and hopes to do spare-time operating on 160-6 CW, SSB and digital modes

OHDEN Has Some Changes To Tell You About

(from Gary, NJ8BB & Eldon, W5UHQ)

Due to the continued long skip being experienced on 80 meters during the Ohio Digital Emergency Net (OHDEN) training sessions @2145 local time each Tuesday; OHDEN will temporarily go to **Sunday afternoons** at **3:00 - 4:00PM**.

Training will remain on the prime frequency of 3584.5KHz USB +1500 Hz.

Tests show that this time has much better propagation throughout the state and should allow the best propagation currently possible on 80 meter band. We are currently having to use a North Carolina station for NCS relays later in the evening.

Anything beyond local ground wave and this long skip point have not been reliable during this time of year, time of day, and sunspot cycle for the past three years.

At the same time, W5UHQ is going to start an experimental Olivia / FT8 net on 1805.000 USB +1500 Hz during the normal time slot of 21:45 – 22:45 on Tuesdays.

The objective of the 160 meter net will be to perform signal reports and check for traffic quality circuits on 160 meters from county to county and county to SEOC. Hopefully we can get more stations active on this frequency and as many county control stations as possible to try out their capability. Tests thus far have been great from border to border. I currently have six different stations that have checked into that test frequency. There will be no change to our standard mission call up frequencies at this time. Using alternate times and frequencies is already in our SOP. The Ohio Technical Specialist team will be available to assist ECs in putting up at least a compromise antenna for that band.

These changes be in effect from Jan 15 until March 12 (start of daylight savings time). These changes should allow all members interested in improving the 160 meter readiness of this critical statewide connection under all conditions of solar impacted propagation.

Be sure to bring the <u>original</u> and a copy of both your license and any CSCEs you may have to the exam. The cost is \$15.00, and if you wish to pay by check, it should be made out to the ARRL/VEC. Identification with your picture is also necessary, such as a driver's license. The Radio Amateur is:

CONSIDERATE..... never knowingly operating in such a way as to lessen the pleasure of others.

LOYAL.... offering loyalty, encouragement and support to other amateurs, local clubs and the American Radio Relay League, through which Amateur Radio in the United States is represented nationally and internationally.

PROGRESSIVE..... with knowledge abreast of science, a well built and efficient station, and operation beyond reproach.

FRIENDLY..... with slow and patient operation when requested, friendly advice and counsel to the beginner, kindly assistance, co-operation and consideration for the interests of others. These are the hallmarks of the amateur spirit.

BALANCED..... Radio is an ad vocation, never interfering with duties owed to family, job, school or community.

PATRIOTIC..... with station and skill always ready for service to country and community.

LCARA was organized for the purpose of furthering Amateur Radio by increasing the technical knowledge and operating proficiency of radio amateurs through continuing education, public service and acting as a vehicle of communication by, between and with the members of the association. LCARA is an incorporated association chartered under the laws of the State of Ohio and is an exempt organization under section 501 (C) (3) of the Internal Revenue Code.
