### BACKSCATTER

**968 Years Ago:** A supernova is seen by Chinese observers on July 4, 1054. Spotted in the constellation Taurus by Chinese astronomers, the magnitude was unusually large, with the star shining roughly four times brighter than Venus and was visible in daylight for 23 days. It remained visible in the night sky for 653 days. The remnant of that exploding star is now known as the Crab Nebula.

**94 Years Ago:** The first American TV station, W3XK, begins broadcasting from suburban Washington, D.C. on July 2, 1928. Charles Francis Jenkins devised a way to transmit pictures, a process he called radiovision. Rather than using a CRT, his receiving sets relied on a 48-line image projected onto a 6-inch-square mirror to create the picture. He sold several thousand receiving sets, mostly to hobbyists, and, after receiving permission to start an experimental TV transmitting station, aired programming five nights a week. He was the first to air a television commercial, and was fined by the government for doing so. He ultimately shut down in 1932.

**40 Years Ago:** The first ever LCARA fox hunt is won by Jeff, WA8SAJ. All twelve hunters retire to Friendly's to celebrate with "ice cream and BS" (yummy!).

The Lakeland College repeater comes on the air, operating as WB8PHI on 147.255 MHz

**35 Years Ago:** Andy Adams, N8HGI takes over as Patch editor from interim editor Pete, KC8ER. Fran, WA8IMF takes over printing from George, KD8FQ.

**30 Years Ago:** Sparky the Rooster takes up residence in the CW barn at Field Day. Although his perch in the rafters was directly above the open bags of potato chips and pretzels, no digestive problems were reported.

**25 Years Ago:** There is major damage to the MIR space station when it's Progress supply ship collides with it during docking. Although communications are severely limited, US astronaut-ham Mike Foale, KB5UAC is able to get news to his family during the crisis.

When will they ever learn? Yet another bigger & better study by the National Cancer Institute finds no evidence that electric power lines causes leukemia in children.

**20 Years Ago:** A 2000' tower is proposed for Governor's Island on the southern tip of Manhattan, to replace the TV broadcasting antennas atop the World Trade Center. Modeled on the Space Needle in Seattle, it would be taller than the Empire State building, and include a restaurant and observation on the top and shops at the bottom. No word was given as to where the repeater antennas would be located.

**VK0 - Macquarie Island** - VK0MQ, Matt Gledhill, continues to be QRV. He started last month and goes to October.

**J2 – Djibouti** - KI7MGY, James, is now in Djibouti until June 2023 and has been issued the call J28HJ. Activity will be on SSB and FT8 and a goal to get on CW. He will be on 80, 40, 20, 17, 15 and 10 meters.

**J2 – Djibouti** - Also in Djibouti, J28RC is the new Riverine Amateur "Riverine" Radio Club at Camp Lemonnier, Djibouti. The ops are on SSB, digital modes, and CW on 80-10M.

**D2 – Angola** - D2TX, Bernie van der Walt, will be in Cuando- Cubango for a 2M EME DXpedition August 12-16.

**D2 - Angola** - Mikalai, UT6UY is QRV as D2UY. Activity is mainly on 20 to 6 meters using FT8. His length of stay is unknown.

**J3 – Grenada** - N9GB, Greg, will be vacationing and operating holiday style from a resort on Grenada between August 12 and 19. He is hopeful to get a J38xx call sign. If not he will be operating as J3/N9GB. Activity will most likely take place after 0000Z with some "daytime operation occasionally". Activity will be on 7 through 28 MHz including the WARC-79 bands and 6 meters. He will be mostly on CW and SSB and then FT8.

JX - Jan Mayen - On JX/LB4MI, Helge, may be found on 20 CW between 1500 and 2200Z.

**VP8 – Falkland Islands** - 2E0KZN, Jonathan, is now working at the Royal Air Force (RAF) Mount Pleasant Complex in the Falkland Islands until early November. While there he will be emphasizing winter SOTA activations as VP8TAA/P.

**4W – Timor – Leste** - Alan, VK1AO will be QRV as 4W/VK1AO from July 25 to August 4, and again at least two more times over the next three years. Activity will be on 40, 30, 20, 17, 15, and 12 meters SSB, FT8, JS8, and possibly some CW.

**BV - Taiwan** - Ken, BW2/JP1RIW is QRV as BX0QSL from New Taipei City until November 30. Activity is on the HF bands using mainly digital modes.

**TA - Turkey** - Berkin, TA3J is QRV as TA3J/0 from Yassica Island, IOTA AS-099, every Saturday and Sunday until October 31. Activity is on 80 to 10 meters using SSB, CW, RTTY, and FT8.

**ZL7 - Chatham Islands** - ZL7. Volker, ZL1VV is QRV as ZL7/ZL1VV from Te One. Activity is in his spare time, and usually on 20, 15, and 10 meters using SSB.

# HAM EXAMS AT THE KIRTLAND LIBRARY

The Lake County Amateur Radio Association's VE Team will be holding amateur radio license exam sessions on the following dates during 2022:

Saturday, August 6

Saturday, October 1

Saturday, December 3

This bi-monthly schedule is the first Saturday of every even-numbered month (e.g., February being the second month, etc.). The Kirtland Public Library is located at 9267 Chillicothe Road, 1.7 miles south of I-90 on Route 306 (Chillicothe Rd). The library is on the left, just beyond the Marathon gas station.

The tests will start at **12 noon.** Please arrive a few minutes earlier.

To register, you will need a NCVEC 605 Form, which will be available at the test. If you would like to complete one ahead of time, be sure it is the Sept 2017 version or later. You can find it by Goggling "NCVEC quick-form 605" and clicking on the URL for a copy of the form. Please note **the FCC requires you to provide a FRN** (FCC Registration Number). Social Security Numbers are no longer accepted. If you are new to ham radio and don't have a FRN, Google "New FRN" and follow the apps.fcc.gov link.


If you are currently licensed, be sure to **bring a copy of your license to the exam.** The cost of the exam is \$15.00, and if you wish to pay by check, it should be made out to the ARRL/VEC. Identification with your picture, such as a driver's license is also necessary.

**In addition** the FCC now charges \$35 to add you to the Amateur Radio database. The FCC will e-mail successful candidates with instructions for payment directly to them. Payment must be made within 10 days of the e-mail. This charge does not apply to upgrades.

BALANCED..... Radio is an ad vocation, never interfering with duties owed to family, job, school or community.

PATRIOTIC..... With station and skill always ready for service to country and community.
