Backscatter for November 2023

BACKSCATTER

77 Years Ago: The first U.S. coin-operated operated TV was introduced. Named the Tradio-Vision, it required 25 cents. It contained 20 tubes and a 5-in cathode ray tube that reflected a 500-line image on mirror on the lid of its metal cabinet.

53 Years Ago: A patent is issued to Doug Engelbart for the computer mouse - an "X-Y Position Indicator for a Display System" (No. 3541541). He and his colleagues called it a "mouse," after its tail-like cable. It was a simple hollowed-out wooden block, with a single push button on top.

45 Years Ago: Plans are underway to move the repeater to a new site on the roof of the hospital in downtown Painesville. 60' of tower are purchased, along with a Phelps Dodge four dipole array.

Plans are also underway for the first ham fest. WB8ZWR, Wayne, chairs a committee to "organize the whole show".

40 Years Ago: The FCC surprises the amateur community by authorizing 13 regional VEC's, rather than the single national VEC as was expected. The FCC plans to continue tests at its own Regional Bureaus, but on a reduced scale.

Cambodia is active! XU1SS and XU1KC are on the air and will count for DXCC credit, despite four governments claiming control of the country: Heng Samrin, Prince Sihanouk, Pol Pot and Son Sann.

35 Years Ago: LCARA's 220 MHz repeater comes on the air, despite occasional QRM from WMMS. It seems the 2nd harmonic of many FM receivers' local oscillators are in the 220 band.

30 Years Ago: We're #4. Early indications from the ARRL shows LCARA's Field Day team placing 4th nationally of all classes!

We're #1. KQ8M, Tim, places first in the CW Worldwide DX CW contest in the single-op, all band, packet assisted category. And Pat, N8ONI, places first in the fox hunt at the Atlanta, Georgia Monitoring Times Convention.

LCARA's roster shows 207 members!.

25 Years Ago: Form 605 is born. Form 610 RIP.

20 Years Ago: We're #1. LCARA's Field Day team places first in class 7A.

15 Years Ago: The repeater's 2 Meter antenna is having problems repeating. The Board purchases a replacement antenna.

10 Years Ago: Bob Liddy, K8BL describes turning an EICO 723 CW transmitter into a bomb by wiring a power supply electrolytic capacitor backwards.

HAM EXAMS in 2023 held at KIRTLAND PUBLIC LIBRARY

The Lake County Amateur Radio Association is once again holding its Amateur Radio license exams at the **Kirtland Library**, 9267 Chillicothe Road, on the following remaining dates in 2023:

Saturday, December 2

This bi-monthly schedule is the first Saturday of every even-numbered month (e.g., February being the second month, etc.). They are held at the Kirtland Library, 9267 Chillicothe Road. It is 1.7 miles south of I-90 on Route 306 (Chillicothe Rd). The library is on the left, just beyond the Marathon gas station.

The tests will start at **12 noon.** Please arrive a few minutes earlier.

To register, you will need a NCVEC 605 Form, which will be available at the test. If you would like to complete one ahead of time, be sure it is the Sept 2017 version or later. You can find it by Googling "NCVEC quick-form 605" and clicking on the url for a pdf of the form. Please note **the FCC requires you to provide a FRN** (FCC Registration Number). Social Security Numbers are no longer accepted. If you are new to ham radio and don't have a FRN, Google "New FRN" and follow the fcc.gov link.

If you are currently licensed, be sure to **bring a copy of your license to the exam.** The cost of the exam itself is \$15.00, and if you wish to pay by check, it should be made out to the ARRL/VEC. Identification with your picture is also necessary, such as a driver's license. If you have any questions, please contact Scott Farnham, KO8O, at (440) 256-0320, or scottfarnham@roadrunner.com

In addition to the \$15 test fee, the FCC now charges \$35 to add you to the Amateur Radio database. The FCC will e-mail successful candidates instructions for payment directly to them. Payment must be made within 10 days of the e-mail. This charge does not apply to upgrades.



LICENSE RENEWAL (revised)

Doing our VE Tests, I often am asked how to renew one's license. It's been five years since I checked, so it seems time to check how much the process has changed. The answer is ... \$35. Starting about a year ago, the FCC has added a fee to update the database. Now there are two steps:

Step 1: Request an upgrade with the FCC. This costs between zero and \$15, depending on how you go about it. These \$\$ go to the ARRL or W5YI (see below).

Step 2: Then pay \$35 directly to the FCC.

STEP 1:

This can be simple and free, or cost \$8, or cost \$15, or be a real PITA. Renewals can only be made within 90 days of expiration. If you're a little late, don't sweat it, as there's a two year grace period.

There are several ways you can go about requesting your license be renewed:

- 1. If you're an ARRL member (you are, aren't you ... it is the best deal in amateur radio, and they need your support to defend our frequencies), fill out the NCVEC Form 605, available in pdf from several sources if you Google "NCVEC Form 605". Then mail it with a note that it's a renewal request to: ARRL/VEC at 225 Main St, Newington CT 06111. It's free. If you do this, make sure your Form 605 is the Sept 2017 version or later, and include your FRN, which is probably on your current license. Check the "FCC ULS" database if it isn't. Note that social security numbers are no longer are accepted.
- 2. If you're not an ARRL member, you can do the same thing, but enclose a \$15 check payable to ARRL/VEC with the form...

- 3. You can have W5YI do it for you at www.w5yi.org Click on "License Renewals" along the left side of the screen and follow the instructions. This costs \$8. Or mail a completed NCVEC Form 605 and \$8 to them at W5YI-VEC, PO Box 200065, Arlington, TX 76006-0065
- 4. You can do it yourself directly with the FCC. Google "FCC ULS" Click on "UNIVERSAL LICENSING SYSTEM" then click "FILE ONLINE" which takes you to the FCC License Manager page and follow the instructions. This is NOT easy. Note that it has been reported the FCC no longer accepts paper requests for renewal.

If you really don't have a FRN number, on the FCC License Manager in 4 above, click on "Register with the FCC" and follow the instructions. Be sure to link your new FRN with your existing license. After receiving a FRN, you can go back to the ULS Home Page and click on ONLINE FILING to request an update/renewal to your license..

Regardless of which method you choose, if the US Postal Service is not involved, it may be as quick as one or two days. You are now ready go on to

STEP 2:

The FCC will e-mail you a request to pay \$35 via a credit card. This must be done within 10 business days. They will then change the database to show your new expiration date. They no longer mail licenses; you have to print it out from the FCC ULS site.
